INTRODUCTION

The purpose of this circular is to provide the Shareholders and Depository Interest Holders with information reasonably necessary for them to make a decision on whether to vote for or against the resolutions to be proposed at the AGM for the approval of, inter alia:

- (a) re-election of the Directors; and

- (b) the grant of the Issue Mandate and Repurchase Mandate to the Directors to issue new Shares and repurchase Shares.

RE-ELECTION OF DIRECTORS

In accordance with Bye-Laws 88(1), at each annual general meeting of the Company, one third of the Directors for the time being (or if their number is not a multiple of three, then the number nearest to but not less than one third) will retire from office by rotation. The Directors to retire every year will be those who have been longest in office since their last re-election or appointment but as between persons who became or were last re-elected as Directors on the same day those to retire will (unless they otherwise agree among themselves) be determined by lot.

This year, in accordance with the Company's Bye-Laws, Mr. Cheung Wai Sun, Mr. Pang Yi, Mr. Ip Chi Ming and Dr. Lui Ming Wah, SBS, JP will retire at the AGM of the Company and all of them, being eligible, offer themselves for re-election.

Biographical details of the above Directors are set out in Appendix II to this circular.

PROPOSED GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

Special resolutions will be proposed at the AGM to grant to the Directors new general mandates:

- (i) to allot, issue and otherwise deal with new Shares with an aggregate nominal amount not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution; and
- (ii) to repurchase Shares with an aggregate nominal amount not exceeding 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution.

In addition, a separate special resolution will also be proposed at the AGM to add to the Issue Mandate those Shares repurchased by the Company pursuant to the Repurchase Mandate (if granted to the Directors at the AGM).

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,219,471,182 Shares. Subject to the passing of the relevant resolution at the AGM, the Company will be allowed under the Issue Mandate to issue, allot and deal with a maximum of 121,947,118 Shares on the basis that no further Shares will be issued or repurchased between the Latest Practicable Date and the AGM.

An explanatory statement containing information required by the Hong Kong Listing Rules to enable the Shareholders to make an informed decision on whether to vote for or against Resolution 7 to be proposed at the AGM regarding the Repurchase Mandate is set out in Appendix I to this circular.

RECOMMENDATION

The Directors consider the re-election of the retire Directors, the Issue Mandate and the Repurchase Mandate are in the interests of the Company and the Shareholders. The Directors unanimously recommend that Shareholders vote in favour of the resolutions 1, 2, 3(b), 3(d), 4, 5, 6 and 7 as set out in the AGM Notice. The Directors, by majority, recommend Shareholders vote in favour of resolutions 3(a) and 3(c) as set out in the AGM Notice.

GENERAL INFORMATION

Your attention is drawn to the additional information set out in the Appendices to this circular. The English text of this circular shall prevail over the Chinese text for the purpose of interpretation.

This appendix includes an explanatory statement required by Rule 10.06(1)(b) of the Hong Kong Listing Rules to be presented to Shareholders concerning the Repurchase Mandate proposed to be granted to the Directors.

1. SHAREHOLDERS' APPROVAL

The Hong Kong Listing Rules provide that all share repurchases on the market by a company with its primary listing on the HKSE must be approved in advance by an ordinary resolution, which may be by way of general mandate, or in relation to specific transactions.

2. FUNDING OF REPURCHASES

Any repurchase will be made out of funds which are legally available for the purpose in accordance with the memorandum of association of the Company and the Bye-Laws, the Hong Kong Listing Rules, the AIM Rules, the rules of PLUS Markets and the laws of Bermuda. The laws of Bermuda provide that such repurchases may only be effected out of the capital paid up on the repurchased shares or out of the funds of the Company otherwise available for dividend or distribution or out of the proceeds of a fresh issue of Shares made for the purpose. Any premium payable on a repurchase over the par value of the Shares to be repurchased must be provided for out of funds of the Company otherwise available for dividend or distribution or out of the Company share premium account before the Shares are repurchased.

As compared with the financial position of the Company as at 30 June 2012 (being the date to which the latest audited financial statements of the Company have been made up), the Directors consider that there might be a material adverse impact on the working capital and on the gearing position of the Company in the event the proposed repurchases were to be carried out in full during the proposed repurchase period.

The Directors do not have present intention to repurchase any Shares and do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital of the Company or the gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

3. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,219,471,182 Shares.

Subject to the passing of the relevant resolutions to approve the general mandates to issue and repurchase Shares and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the AGM, the Company would be allowed under the repurchase proposal to repurchase a maximum of 121,947,118 Shares during the period ending on the earlier of (i) the conclusion of the next annual general meeting of the Company; or (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Bye-Laws or any applicable laws to be held; or (iii) the revocation or variation of the authority given under the aforesaid resolutions by a special resolution of the Shareholders in a general meeting.

4. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders to have a general authority from the Shareholders to enable the Company to repurchase its Shares on the Market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and the Shareholders.

5. UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the HKSE to exercise the Repurchase Mandate in accordance with the Hong Kong Listing Rules, the AIM Rules, the rules of PLUS Markets, the applicable laws and regulations of Bermuda and in accordance with the memorandum of association of the Company and the Bye-Laws.

6. EFFECT OF THE HONG KONG TAKEOVERS CODE

If a Shareholder's proportionate interest in the voting rights of the Company increases as a result of the Directors exercising the powers of the Company to repurchase its Shares pursuant to the Repurchase Mandate, such increase will be treated as an acquisition of voting rights for the purpose of Rule 32 of the Takeovers Code. Accordingly, a Shareholder or group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

To the best of the knowledge, information and belief of the Directors and on the basis of the shareholding of the Company as at the Latest Practicable Date, the Directors are currently not aware of any consequences which will arise under the Takeovers Code as a result of any purchase of Shares made under the Repurchase Mandate, since none of the substantial Shareholders would hold 30% or more of the shareholding of the Company after the repurchase.

The Hong Kong Listing Rules prohibit a company from making repurchase of shares on the HKSE if the result of the repurchase would be that less than 25% (or such other prescribed minimum percentage as determined by the HKSE) of the company's issued share capital would be in public hands. The Directors do not propose to repurchase Shares which would result in less than the prescribed minimum percentage of Shares in public hands.

7. DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective associates have any present intention, in the event that the proposed Repurchase Mandate is approved by the Shareholders, to sell Shares to the Company. No connected person of the Company has notified the Company that he/she/it has a present intention to sell Shares to the Company nor has he/she/it undertaken not to sell any of the Shares held by him/her/it to the Company in the event that the Company is authorised to make repurchases of Shares.

The biographies of the Directors who will be seeking re-election are set out below.

Mr. CHEUNG Wai Sun, Executive Director

Mr. Cheung Wai Sun, age 53, joined the Board on 18 November 2003. He has over 10 years extensive knowledge and experience in the agricultural business in the PRC. He was a member of the Chinese People's Political Consultative Conference Guangdong Province Meizhou Municipal Committee and a general committee member of the Hong Kong Federation of Guangdong Hakka Associations.

Save as disclosed above, Mr. Cheung does not hold any positions with the Company and other members of the Group and did not hold any directorships in the last three years in other listed companies. Mr. Cheung is not related to any other directors, senior management or substantial shareholders of the Company.

As at the Latest Practicable Date, Mr. Cheung had personal interests of 1,200,000 share options under the share option scheme within the meaning of Part XV of the SFO.

Mr. Cheung has entered into the service agreement with the Company. His remuneration package includes basic salary, benefits and share options. For the financial year ended 30 June 2012, total amount of his emoluments was approximately RMB1,163,000.

Mr. Cheung is not appointed for a specific term but subject to retirement by rotation and re-election at the AGM pursuant to the Bye-Laws. Mr. Cheung will retire and being eligible, will offer himself for re-election at the AGM.

Save as disclosed above, there are no other matters concerning Mr. Cheung that need to be brought to the attention of shareholders and there is no other information to be disclosed pursuant to the requirements of Rule 13.51(2) of the Hong Kong Listing Rules.

Mr. PANG Yi, Deputy General Manager of the Hepu Plantation

Mr. Pang Yi, age 43, joined the Group in 2000 as the Deputy General Manager of the Hepu Plantation and was appointed as an Executive Director on 16 June 2005. He is responsible for the Group's overall operation and management in the PRC. He obtained a bachelor's degree in plantation economic management from the Northwest Sci-Tech University of Agriculture and Forestry in 1995. Mr. Pang had been appointed by Guangxi Foreign Trade and Economic Cooperation Department as investment service supervisor of Guangxi Zhuang Autonomous Region from 2002 to 2005. He was also a member of the Chinese People's Political Consultative Conference Hepu County Committee.

Save as disclosed above, Mr. Pang does not hold any positions with the Company and other members of the Group and did not hold any directorships in the last three years in other listed companies. Mr. Pang is not related to any other directors, senior management or substantial shareholders of the Company.

As at the Latest Practicable Date, Mr. Pang had personal interests of 452,043 ordinary shares and 5,740,000 share options under the share option scheme within the meaning of Part XV of the SFO.
